The following rules apply to ALL parade entrants and will be strictly enforced:

1. Parade starts at the intersection of Lancaster Boulevard and 10th St. West.
2. **Absolutely NO articles are to be thrown or distributed along the parade route. Any entry doing so will be removed IMMEDIATELY from the parade without refund.**
3. No alcoholic beverages allowed. This will be strictly enforced by parade officials and the Sheriff's.
4. All entries must be suitably decorated so as to have "parade value." Entry number must be visibly displayed on windshield or right side of entry.
5. Entries in float categories are limited to one unit driven and one unit pulled, and entry must relate to theme.
6. **CHILDREN UNDER THREE YEARS OF AGE** are to be transported; that is, not walking or marching.
7. Any procedure or performance that disrupts or halts orderly procession of parade is strictly prohibited.. Maximum distance between each entry is 50 feet. **NO STOPPING – YOU WILL BE REMOVED FROM THE PARADE IMMEDIATELY REGARDLESS OF REASON.**
8. Car Clubs and decorated cars must conform to parade theme; those cars of car clubs not decorated appropriately will be pulled from the parade without refund.
9. All applications will be considered for acceptability by the Parade Committee. Notification of acceptance will be based on "parade value" as described on parade application one week prior to the parade.
10. Parade will commence rain or shine.
11. **No stallions or unruly animals will be allowed. Any equestrian or entry with animals must be in complete control of their animals and are required to have a cleanup person for the Animals waste.**

Antelope Valley Chambers of Commerce Waiver and Release of Liability

1. This waiver and release is intended to and does release Antelope Valley Chambers of Commerce from any and all liability for damages or injuries on account of or in any way related to or growing out of my negligence, the negligence of third parties and Antelope Valley Chambers of Commerce's negligence. This is not intended to release Antelope Valley Chambers of Commerce from any liability resulting from their intentional conduct.

I further covenant and agree not to institute any claims or legal action against Antelope Valley Chambers of Commerce for any claim released by this Agreement. I further agree that should any claim be made against Antelope Valley Chambers of Commerce in contravention of this Agreement, including but not limited to derivative claims, I will protect, defend and completely indemnify (reimburse) Antelope Valley Chambers of Commerce for any such claim and expenses including attorney's fees and costs incurred by Antelope Valley Chambers of Commerce in defending themselves or security indemnity hereunder.
